
Why The Fire Tax District

BLACKSBURG VOLUNTEER FIRE DEPARTMENT INTENT & PURPOSE

The Blacksburg Volunteer Fire Department has an annual county budget of \$46,500 in expenses, but it receives \$0.00 of its operating budget income from fire property taxes. There has never been an increase in the rate of property taxes since the District's formation in the late 1900's. Since then there have been significant increases in insurance costs, fuel costs, life safety equipment, maintenance expenses, and operations cost. The District has been relying on donations to cover the difference between its annual expenses and its limited revenues. It is no longer feasible to rely on these sources as the Blacksburg Volunteer Fire Department's Board Members has determined that it is necessary to impose a Fire Tax on all of the landowners within the Fire District to produce enough revenue to meet the district's expenses. The proposed Fire Tax upon landowners within the Fire Protection District. This tax would be collected by the Cherokee County Tax Collector to be included upon the annual property tax bills to landowners, starting ______.

The Blacksburg Volunteer Fire Department has provided effective, low cost public safety services to the residents, property owners and businesses within the district for over 130 years, while depending on volunteer firefighters to provide outstanding fire protection services. The modest Fire Tax being proposed will ensure the continued viability of this district at a low cost, high benefit for everyone within the fire district.

A PUBLIC QUESTION:

<u>"TO LEVY A FIRE TAX TO PROVIDE FIRE PROTECTION</u> <u>SERVICES"</u>

Blacksburg Volunteer Fire Department Fire District:

SHALL the Blacksburg Volunteer Fire Department levy a Fire Tax at a rate not to exceed 15 Mills (\$0.015 or 1.5 cents per \$100.00) of the value of all taxable property within the Blacksburg Volunteer Fire District? This proposal would be used for Life Safety Equipment, Maintenance and Operations, Staffing Personnel, and Repairing Fire District's Infrastructure to enhance the current level of fire protection services to residents throughout Blacksburg Volunteer Fire Department Fire District to avoid a significant reduction in the level of services presently being provided.

Fire Tax District figures and General Information

County Petition Needed = 10% of 660 = 66

Votes needed to pass = 51% of 660 = 336

Example:

Home Value = \$50,000 Percentage = 4% Millage Rate = 15Mills = \$50,000 x 0.04% x 0.015 = \$30 Per Year

WHAT's THE COST?

Blacksburg Fire Department is seeking what is termed as "**15 Mills**." This simply means that the tax rate is \$0.015, or 1.5 cent per \$100. The table below will provide estimated examples:

A HOUSE FIRE WILL

DOUBLE IN SIZE EVERY 30-60 SECONDS

Fire doubles in size every 30-60


seconds. Materials in a room fire can simultaneously ignite(flashover) in as little as 4 minutes. Once flashover takes place, there is little or no chance for survival. The amount of time it takes to receive this help can double.



After 8 minutes, a Non-breathing person Has little chance for Survival.

- Safety for firefighters with out of date life safety equipment.


